**MINUTES OF THE REGULAR MEETING OF NOVEMBER 11, 2015**

CALL TO ORDER: The Regular Meeting of the Board of Township Trustees was called to order by Supervisor Tarulis at 7:35 p.m. at the Lisle Township office, 4711 Indiana Avenue, Lisle, IL.

**Approval of October 14<sup>th</sup>, 2015 Regular Meeting Minutes:**

Trustee Buch motioned for the approval of the minutes from the October 14<sup>th</sup> regular board meeting. Trustee Connell seconded the motion.

Motion was approved by unanimous voice vote.

### **Resignation of Trustee:**

Trustee Sharon Connell tendered her resignation. Mrs. Connell told the board that this was a bitter-sweet moment, but she has accepted an offer to work for the highway department. To avoid any conflicts, her resignation is effective immediately.

Mrs. Connell stated that she has been an employee of the Village of Downers Grove for 12 years and that the role of administrative assistant with the highway department is very similar to the position she has held with the village.

Supervisor Tarulis and the board thanked Mrs. Connell for her service and wished her good luck in her new role.

The supervisor then advised the board that he has directed his assistant, Mr. Vondran to prepare a "Notice of Vacancy in Office" to fill the position. He then outlined his plan to fill the vacancy; which is to ask that all who are interested in filing to do so by early December so that the board can review the applicants at the December meeting and then decide how to proceed. The vacancy must be filled by the board within 60 days.

### **Approve Health Insurance Renewal:**

The supervisor referred to the renewal documents prepared by Esser Hayes. Mr. Tarulis noted that the 2016 premiums for the township reflected a 5% decrease. Highway Commissioner Young then informed the board that the highway department is looking into different programs for their health care coverage. This is because he believes that there may be better plans for his department and that he further informed the board that he may change carriers at some point during the new policy period.

Highway Commissioner Young committed to the board that he would not change the highway department's coverage if it would affect the health care coverage for the rest of the township's employees. Supervisor Tarulis then expressed his concerns regarding the highway department utilizing a state-administered plan for their health care. Commissioner Young then told everyone that he was considering a few different options.

The board then discussed whether the highway department was enough of a separate entity to have a separate health care plan. David Streich of Esser Hayes then attempted to clarify the issue handing out a document which outlined what Blue Cross uses as a standard to determine if an entity is a single or are multiple entities.

The discussion ended with the highway commissioner stating that he had made no final decision as to when, or which potential option his department might take advantage of in the next year.

A motion was made by Trustee Tams to approve the renewal of the current health insurance plan for Lisle Township employees effective December 1, 2015. The motion was seconded by Trustee Riedy.

### **Discuss and Approve ICRMT Insurance:**

The supervisor explained that this group of policies essentially covers the townships assets as well as workman's compensation. He then introduced Rob Gaylord of Conner & Gallagher, who explained that coming year's policies offer the same coverage as this year, with one additional coverage, which was added for the highway department's gas pumps. Rob then explained that by shopping these policies to various carriers, he was able to save the township approximately \$30,000. He noted that one reason the workman's compensation insurance went down significantly was not only did the township have a good year with regard to workers injuries, but also the township had participated and worked with carriers on programs to minimize risk in the future.

The board discussed the coverages and confirmed that the deductibles' and policy limits remained the same. Once the board was satisfied that all of its questions were answered, the supervisor asked if someone would like to make a motion.

Trustee Tams motioned to approve the renewal of ICRMT insurance plan for Lisle Township with the pollution liability addendum providing additional coverage. Trustee Buch seconded the motion.

### **Budget Hearing, Town and General Assistance:**

The supervisor called the public hearing to order at 8:05 PM on the town and general assistance fund.

The township assessor stated that he would like to update his budget line for contingencies by adding twenty thousand to it. This is necessary given the potential expenses related to the mold



found in his building. The current plan is to temporarily move his staff next door while the board makes a decision on what is necessary to fix the building he has occupied. He is waiting to receive a lease so that he can make a decision regarding the temporary move. Mr. Trowbridge told the board that this problem has happened at a very precarious time in the assessor's office calendar. The assessor's department is about to publish its assessment of the township's property values in the next 10 days. This publication and the subsequent hearings make this a very busy time for his office. It was also noted by the assessor that while he was responsible for the moving costs of his staff, the supervisor's office is responsible for the building costs.

It was noted that this addition is to line 10-14-19 of the assessor's budget will be changed from \$20,000 to \$50,000.

Trustee Tams moved to close the budget hearing at 8:21p.m. The motion was seconded by Trustee Riedy.

Motion was approved by unanimous voice vote.

**Budget Hearing, Road District:**

Supervisor Tarulis called the road district budget hearing to order at 8:22 p.m.

There was a brief narrative on the budget by the highway commissioner and he noted that his budget has no changes since it was posted.

Trustee Tams moved to close the budget hearing at 8:24 p.m. The motion was seconded by Trustee Riedy.


