LISLE TOWNSHIP ORDINANCE 2021- 2

An ordinance levying taxes for all town purposes for Lisle Township, DuPage County, Illinois, for the tax year 2021 collectible in 2022.

WHEREAS, the Supervisor and Board of Trustees have previously adopted a budget for fiscal years 2020 and 2021, and determined the estimated amount of funds to be raised by taxation for the year 2020; and

NOW THEREFORE, be it ordained by the Supervisor and Board of Trustees of Lisle Township, DuPage County, Illinois as follows:

SECTION I: That the sum of Two Million, Two Hundred Thirty Five Thousand, One Hundred Dollars (**\$2,235,100.00**) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

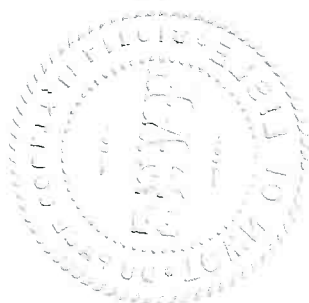

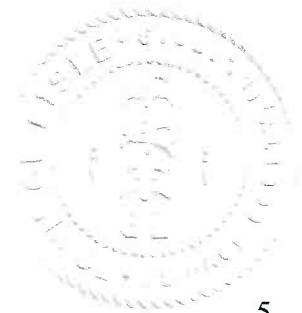
