The amount of taxes extended on behalf of Lisle Township for fiscal year 2012-2013 was **\$218,502.00.**

The balance on April 1, 2012, of all the money in the accounts of Lisle Township was **\$406,343.00.**

The total amount collected and paid to me as the Chief Executive Officer and Treasurer for all accounts of Lisle Township for this fiscal year was **\$219,648.00.**

The amount available was **\$625,981.00.**

The total amount paid out from all accounts of Lisle Township for this fiscal year was **\$211,338.00.**

The balance on March 31, 2013 of all the money in accounts of Lisle Township was **\$414,643.00.**

A detailed accounting showing all accounts is included in the attachments hereto.

Lisle Township has no outstanding debts due and unpaid, nor any kind of indebtedness not yet due.
