**MINUTES OF THE REGULAR MEETING OF APRIL 10, 2012**

CALL TO ORDER: The Regular Meeting of the Board of Town Trustees was called to order by Supervisor Clarke at approximately 9:00 p.m., following the Annual Meeting, at the Lisle Township office, 4711 Indiana Avenue, Lisle, IL.

2. Public Comments: None.

3. Approval of Minutes: Motion by Trustee Tams to approve the minutes of the March 14, 2012 regular Town Board meeting. Second by Trustee Klaeren. Voice vote, all in favor, motion passed.

Motion by Trustee Tams to approve the minutes of the March 21, 2012 special Town Board meeting for the budget and abatement approval. Second by Trustee Klaeren. Voice vote, all favor, motion passed.

Assessor Trowbridge arrived at 8:55 p.m., following a meeting with residents after the annual meeting.

4. Mosquito Abatement: Supervisor Clarke handed out the annual report from Clarke Mosquito (no relation) for discussion. The service will remain the same for this year with no cost increase, and a cost increase of 3% or the cost-of-living, whichever is less, in years two and three. Motion by Trustee Modica to approve the agreement for mosquito abatement services with Clarke Mosquito as presented. Second by Trustee Voras.

5. Other Business: Clerk Tarulis confirmed that the salary disclosure notice is on the website, and the employee salaries and compensation packages are available for inspection at the office. Clerk Tarulis also requested that the Board consider allowing IMRF service credit for employees who served in the military. There is a procedure for the employee to purchase service credit for up to four years of active duty military service, but the Board must adopt a Resolution. Trustees agreed to place the topic on next month's agenda.

6. Audit of Expenditures:

Motion by Trustee Klaeren to audit expenditures. Second by Trustee Tams. Voice vote, all in favor, motion passed.

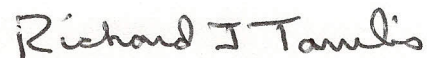
