**Approval of the April 9, 2019 Regular Meeting Minutes:**

Trustee Chatman made the motion to approve the April 9, 2019 Meeting Minutes. The Motion was Seconded by Trustee Tams.

### **Reports of Elected Officials:**

#### **Highway Commissioner Young:**

Commissioner Young reported that the highway crews were recently sent out for two snowfalls and over six inches of rain.

The crew also attended a storm-water training session on April 10 at DuPage County.

Highway department mechanic Brad Pick and his wife are proud parents of a new baby.

Bid opening: asphalt prices have been going up, but the quantity was lower, resulting in a 4% lower bid from last year.

Commissioner Young is working on the final traffic patterns around the new school in Lisle. The sheriff is concerned over the estimated 135 cars and school busses that will be turning from 59<sup>th</sup> St. The commissioner will be meeting with the sheriff on Friday to review the traffic flow.

Trustee Chatman discussed some of the details regarding a small number of students who live in an area with no sidewalks. She also mentioned that the elected officials were invited to tour the new school.

#### **Assessor Trowbridge:**

During the last storm, the assessor was on site on Burlington Ave. The county crews worked the site from early afternoon until well into the next morning. Also there, was the Lisle mayor, who asked the assessor that he not make a hasty decision regarding the location for the assessor's office. Assessor Trowbridge replied that he does not pick the place, the township board does.

The assessor also mentioned that a nearby house was destroyed by fire during that storm.

### **Supervisor Mullen:**

Supervisor Mullen began her report by addressing the assessor's conversation with the Lisle mayor. She wants architectural information from the village. When getting closer to choosing a location, we can list side-by-side options of each prospective location and how it fits the needs of the assessor's office. Assessor Trowbridge stated that he has a list of line items.

Supervisor Mullen then mentioned two events at the township campus, the shred day held in April, and the Triad Car Care Safety Clinic for Seniors to be held on May 11.

Trustee Chatman made a Motion to approve the audit of the expenditures. Trustee Tams Seconded the Motion.


