4. Discussion of Health Insurance Renewal: Supervisor Clarke reported that the health insurance premiums are estimated to be going down approximately 11%. Bill Edson will be at the next meeting to give details and answer questions.

5. Sale of Real Estate – 146 N. Sleight St.: Supervisor Clarke noted that two appraisals were handed out at the last meeting, and we have received a memo from Attorney Monson on the procedures we have to follow. We will have an executive session at the end of this meeting.

6. Discussion of Elected Officials' Salaries: Supervisor Clarke said there is nothing prepared for discussion, and this will be on next month's agenda. The salaries have to be set no later than our November meeting.

7. Reports of Elected Officials: Supervisor Clarke handed out artwork which may become a new Township flag and logo. He is working on it with staff. Highway Commissioner Dow is still recovering but is unable to make it tonight.

8. Other Business: Copies of the final Annual Audit were handed out. The Audit was previously reviewed and approved, and the final draft incorporates all comments. Trustees are requested to return the originals at next meeting.
