RESOLUTION NO. 2023-005

A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH PACE TO JOIN ITS MUNICIPAL VEHICLE PROGRAM

WHEREAS, Article 7, Section 10 of the Illinois Constitution of 1971 and the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., allows public entities to enter into intergovernmental agreements in the furtherance of their government purposes; and

WHEREAS, Lisle Township is a public entity and wishes to enter into an agreement with Pace, the Suburban Bus Division of the Regional Transportation Authority, an Illinois municipal corporation ("Pace") to provide transportation to the general public, senior citizens, individuals with disabilities, and/or low-income individuals, in a manner that will reduce the number of motor vehicles on the road within the Township's corporate limits; and

WHEREAS, Lisle Township wishes to approve an intergovernmental agreement entitled Municipal Vehicle Program Agreement, which is attached hereto as Exhibit A and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the Supervisor and Board of Trustees of Lisle Township, DuPage County, Illinois, as follows:

<u>SECTION 1:</u> The corporate authorities of Lisle Township hereby approve the Municipal Vehicle Program Agreement, Exhibit A.

SECTION 2: The Supervisor or her designee is hereby authorized to sign and execute the Municipal Vehicle Program Agreement, Exhibit A, on behalf of Lisle Township and any related documents or forms necessary to execute the Agreement.

<u>SECTION 3: SEVERABILITY</u>. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.

SECTION 4: REPEAL OF PRIOR RESOLUTIONS. All prior Resolutions and Ordinances in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

<u>SECTION 5:</u> <u>EFFECTIVE DATE</u>. This Resolution shall be in effect immediately from and after its passage and approval.
