## **ORDINANCE No. 2023-003**

An ordinance correcting the 2022 Tax Levy Ordinance and levying taxes for all town purposes for Lisle Township, DuPage County, Illinois for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Lisle Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of Two Million Three Hundred Fifty Thousand Five Hundred Fifty Dollars (\$2,350,550.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for the year 2022, for the purposes specified herein.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
