**LISLE TOWNSHIP  
ORDINANCE 2016-3**

**An ordinance levying taxes for all town purposes for Lisle Township,  
DuPage County, Illinois, for the tax year 2016 collectible in 2017.**

WHEREAS, the Supervisor and Board of Trustees have previously adopted a budget for the fiscal year 2017, and determined the estimated amount of funds to be raised by taxation for the fiscal year 2017.

NOW THEREFORE, be it ordained by the Supervisor and Board of Trustees of Lisle Township, DuPage County, Illinois as follows:

SECTION 1: That the sum of Two Million, Five Hundred Fifty Six Thousand Dollars (\$2,556,000.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
