LISLE TOWNSHIP
ORDINANCE # 2011-3**

An ordinance levying taxes for all town purposes for *LISLE TOWNSHIP*, *DuPage County*, Illinois, for the tax year 2011 collectible in 2012.

BE IT ORDAINED by the Board of Trustees of *LISLE TOWNSHIP*, *DuPage County*, Illinois as follows:

SECTION 1: That the sum of: Two Million, Three Hundred Fourteen Thousand, Four Hundred Eighty-Five Dollars (**\$2,314,485.00**) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:
