DUPAGE COUNTY, ILLINOIS**

AN ORDINANCE LEVYING TAXES FOR GENERAL FUND AND GENERAL ASSISTANCE PURPOSES FOR THE CURRENT FISCAL YEAR COMMENCING APRIL 1, 2022 AND ENDING ON MARCH 31, 2023

BE IT ORDAINED, by the Supervisor and Board of Trustees of Lisle Township as follows:

SECTION ONE: SECTION 1: A tax for the following sums of money, or as much thereof as may be authorized by law, to defray all expenses and liabilities of the Village, be and same is hereby levied for the purposes specified against all taxable property in the Village of Itasca for the fiscal year commencing on April 1, 2022 and ending on March 31, 2023.
